What is a dividend?

A dividend is the percentage of a company's profits paid to shareholders as at a specified date. The amount each shareholder receives is dependent upon the number of shares the shareholder owns in the company. For example, if TDC Ltd paid a dividend of 20 cents per share, a shareholder who owns 1,000 shares will receive \$200.00 in dividend.
