## What does a Limit Order mean?

A limit order is an order to buy a security for not more than a specified price or to sell a security for no less than a specified price. For instance, an investor buying SKNB shares may instruct his broker to buy for <u>no more than</u> \$3.00 per share, while an investor selling SKNB shares may instruct his broker to sell the shares for <u>no less than</u> \$3.00 per share.
