Summary trading report for the week ending Friday, 22 July 2016

Eastern Caribbean Securities Market

On the Eastern Caribbean Securities Market this week, the following securities traded:

• 1,000 S L Horsford & Co Ltd shares and 400,000 TDC shares crossed the market

Regional Government Securities Market

On the Regional Government Securities Market, the following auctions took place using the primary market platform of the Eastern Caribbean Securities Exchange:

- the Government of Grenadaøs 91-day Treasury bill raised \$15.0 million. The competitive uniform price methodology used, resulted in a discount rate of 3.86244%.
- the Government of Saint Lucia 180-day Treasury bill raised \$25.0 million. The competitive uniform price methodology used, resulted in a discount rate of 2.95626%, and
- the Government of Grenadaøs 365-day Treasury bill raised \$30.0 million. The competitive uniform price methodology used, resulted in a discount rate of 4.7619%.

The next auction scheduled to be held on the Regional Government Securities Market is the Government of Grenadaøs 91-day Treasury bill offered at a maximum rate of 6.0% which will take place on 10 August 2016, using the primary market platform of the Eastern Caribbean Securities Exchange. Bidding for this auction will commence at 9:00 am and end at 12:00 pm.
