1. The company has three main lines of business, namely Mobile, Fixed Line, and Broadband. Whilst there was growth in mobile and broadband revenues, the legacy product streams i.e. domestic fixed line and international outgoing continues to decline. This decline in domestic fixed line revenues is mainly as a result of a shift in the use of fixed to fixed local calls to mobile to mobile calls. The emergence of new technology contributed to the decline in international outgoing revenues.

A significant amount, (63%), was spent on fixed line and mobile. Mobile expenditure related to the continued expansion of the GSM network to satisfy customer growth and improve coverage. Fixed line capex was to upgrade and improve fixed line network which also supports broadband network. The amount reported under other category relates to capex for retail store renovations, time bombs and power. Funds used to finance the above investment were provided by operating activities.

(ii) Results of Operation.

- The emergence of new technologies that offer lower IDD rates, continues to impact revenues from International outgoing revenue. This is evident in the decrease in revenues by 4% when compared to the financial year 08/09.
- As a result of the change in customer calling patterns, (a shift from fixed to fixed calling to mobile to mobile calling), domestic revenue for the 09/10 financial year declined by 9% over the 08/09 year. It is expected that fixed line customers will continue to migrate to the more popular mobile network.
- Internet revenue decreased by 3% over last year mainly as a result of a slight decline in market share due to competition from other providers, however this is expected to turn around in the next financial year with further upgrade and expansion to the broadband network.
- There was a significant increase of 16% in data revenue when compared to 08/09. This was as a result of growth in the IDD leased circuit market.
- Other revenues increased by 11% compared with the previous year which came about from an uplift in new DIA customers.
