And today's financial tip:

What is meant by stock split?

When a corporation issues new shares of stock but in turn lowers the current market price of its stock. For example, if SLES trades at \$25.00 before a 2-for-1 split, after the split it will trade at \$12.50 and holders of the stock will have twice as many shares as they had before the split. So, if Mr Jones has 1,000 shares worth \$25,000.00, after the split he would have 2,000 shares that are worth \$25,000.00.
