What is an Annuity?

An annuity is a contract sold by insurance companies, designed to provide payments to the holder at specified intervals, usually after retirement. The holder is taxed only when they start taking distributions or if they withdraw funds from the account. The term annuity is also used more generally to refer to any series of payments with a set size and frequency.
