1. Business

The group had another successful year despite the unfavourable economic climate. Sales for the year ended 30 September 2010, declined by 14%: from \$147,921,459 to \$127,095,175. Part of this decrease was due to the temporary closure of the company-operated gas station in early 2010. The gas station is expected to re-open in the first half of 2011 under the SOL brand. Management continues its vigilance in the management of its resources which has enabled the company to achieve almost the same level of success as the previous year.

Land and buildings were revalued and resulted in a revaluation reserve of \$24,057,081.

Construction of the supermarket in Baths, Nevis is progressing as planned with a completion date of mid-2011.

The Directors have agreed to recommend to the Annual General Meeting a final dividend of six cents per share. An interim dividend of five cents per share was paid in October 2010.
