Trading Summary

This week saw trading in the shares of Bank of Nevis (BON). 5,090 BON shares traded at \$3.88 per share, down two cents since BON last traded on 1st September.

The Government of Grenada will issue a ninety-one (91) day, fifteen million Eastern Caribbean dollar (EC\$15,000,000) Treasury Bills via a competitive uniform price auction on Tuesday, 18th November, 2003. The minimum bid amount for this Issue is EC\$5,000 and maximum discount rate offered is 5.55 % (or \$98.63).

This is the second Treasury Bill offering by the Government of Grenada on the Regional Government Securities Market, in July 2003 the Government successfully raised EC\$25,000,000 via a one year Instrument.
