Trading Summary

Shares in Dominica Electricity Services Limited (DES), East Caribbean Financial Holding Company Limited (ECFH) and S. L. Horsford & Company Limited (SLH) traded this week. 1,500 DES shares traded at \$2.50 per share DES share price holding firm, 923 ECFH shares traded, up 25 cents per share at \$7.00 and 1,100 SLH shares traded at \$1.90 per share down ten cents on its previous market close.
