What is meant by settling a trade?

In securities markets settling a trade is the process of transferring securities to the buyer and monies to the seller after a trade has taken place. In the Eastern Caribbean Securities Market that process, also referred to as settlement, take place on the working day following the trade. This is referred to as T+1 settlement, T being trade day and T meaning one day after.
