Regional Government Securities Market

Two new issues were auctioned on the Regional Government Securities Market this week.

- Government of Antigua and Barbuda's 365-day Treasury Bill auctioned 13 May 2024, on the ECSE' s Primary Market Platform raised \$30.0 million dollars. The competitive unform price methodology used resulted in a discount rate of 3.66089 percent.
- Government of St. Vincent and the Grenadines 91-day Treasury Bill auctioned 16 May 2024, on the ECSE' s Primary Market Platform raised \$28.0 million dollars. The competitive unform price methodology used resulted in a discount rate of 3.46972 percent.

The following auction scheduled to be held on the Regional Government Securities Market is the Government of Saint Lucia's 91-day Treasury Bill, offered at a maximum rate of 3.5%, which will take place on 21 May 2024 using the primary market platform of the Eastern Caribbean Securities Exchange.
