# **Summary Trading Report for the week ending Friday, 7 March 2025**

#### **Eastern Caribbean Securities Market**

The following is a summary of trades that were executed on the Eastern Caribbean Securities Market this week.

### 3 March 2025

- 50 Grenada Co-operative Bank Ltd shares traded odd lot at \$9.25 per share,
- 20 St Lucia Electricity Services Ltd shares traded odd lot at \$23.00 per share, and
- 100 TDC Ltd shares traded odd lot at \$1.30 per share.

## 4 March 2025

- 1,300 Grenada Co-operative Bank Ltd shares traded at a high of \$9.50 and a low of \$8.87 per share, closing at \$9.35 rising \$0.10 or 1.1% from its last traded price,
- 1,800 TDC Ltd shares traded at \$1.30 per share, rising \$0.15 or 13% from its last traded price,
- 30 Grenada Electricity Services Ltd shares traded odd lot at \$11.75 per share
- 50 TDC Ltd shares traded odd lot at \$1.30 per share, and

## **Regional Government Securities Market**

Two new issues were auctioned on the Regional Government Securities Market this week.

- The Government of St Lucia's 91-day Treasury Bill auctioned 3 March 2025 on the ECSE's primary market platform raised \$16.0 million. The competitive uniform price methodology used resulted in a discount rate of 2.78059%.
- The Government of St Lucia's 6-year Government Bond auctioned 4 March 2025 on the ECSE's primary market platform raised \$20.0 million. The competitive uniform price methodology used resulted in an interest rate of 6.24%.

The next auction scheduled to be held on the Regional Government Securities Market is the Government of Antigua and Barbuda's 365-day Treasury bill offered at a maximum rate of 4.5% which will take place on 18 March 2025 using the primary market platform of the Eastern Caribbean Securities Exchange. Biding for this auction will commence at 9:00 am and end at 12:00 pm.
